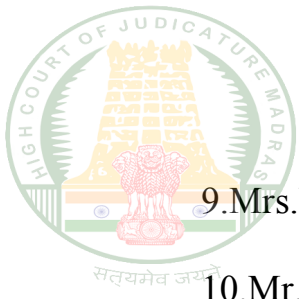

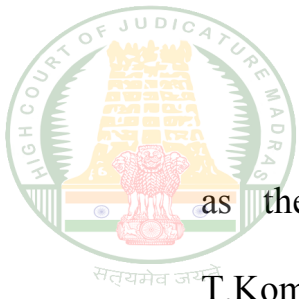
ORDER

(3) Mrs.Suganthi W/o.Mr.Moorthy (Daughter), 11th Respondent herein



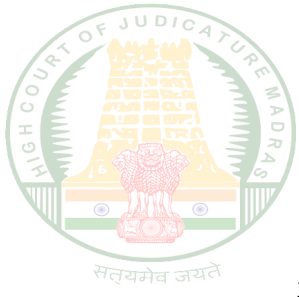
