on date the aforesaid TASMACH Shop No.4082 is functioning only in the aforesaid address and they have no idea to shift the TASMACH shop to any other place.

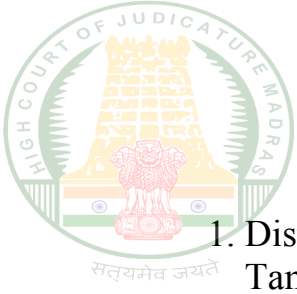
