ORDER

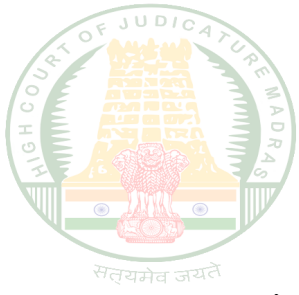
(Order of the Court was made

Mr.Arunachalam opposes the application for condoning the delay of 92 days in filing the appeal and is filing an affidavit in reply. Registry to take the same on record for completion of records.

2. Shri Rajesh Kumar states that he was served a copy only today. Shri. Arunachalam states that applicant has filed an application under Section 16 of the Arbitration and Conciliation Act, 1996 before the learned Arbitrator and in that also, has prayed for vacating the stay granted.
