ORDER

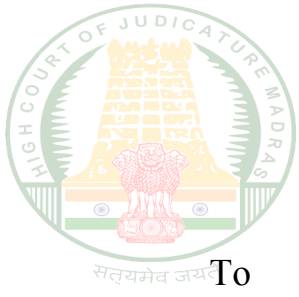
This matter came up for consideration before this Court on 23.06.2025.
