(2D) No.62, Animal Husbandry, Dairying and Fisheries (FS.2) Department, dated 21.07.2010 of the first respondent rejecting my appeal against the order of punishment, as time-barred, to quash the same and to issue consequential directions to the respondents to include his name in the panel for the year 2002-03, approved in G.O. (2D) No.31, Animal Husbandry Dairying and Fisheries (FS.2) Department, dated 24.03.2006, for promotion as Deputy Director of Fisheries in the appropriate place therein and to notionally promote him as such on par with him immediate junior with consequential benefits.
