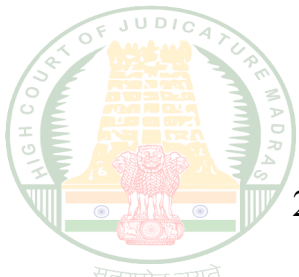

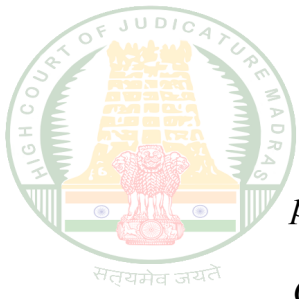


2. A memo dated 03.02.2025 has been filed by the petitioner stating as follows:-

In respect of the very same subject matter which is litigated by petitioner and 1st respondent, writ petitions and public interest litigations in W.P Nos 8618 of 2006, 4950 of 2007, 8624 of 2007, 8625 of 2007 and 4950 of 2007 was pending and finally decided by Division Bench of this Hon'ble Court on 5.10.2007.

3. As against the same, petitioner herein and other aggrieved landowners/Developer have preferred SLP before Hon'ble Supreme Court and leave was granted by Hon'ble Supreme Court. The civil appeals in C.A No 5414-5415/2010, 5423-25/2010 and C.A Nos 5444-5445/2010 are pending. Interim orders have been granted and the appeals are being listed for final hearing.

4. In the light of above facts and subsequent events, petitioner seeks leave of this Hon'ble Court to withdraw the above revision petitions with liberty to file appropriate
