**ORDER**

This Writ Petition has been filed in the nature of a Mandamus seeking a direction to the respondent to disburse Provident Fund, Gratuity and Earned Leave Salary within a stipulated period together with interest at 6% per annum.

2. In the affidavit filed in support of the writ petition it had been stated that the petitioner had joined service in Annai Sathiya Transport Corporation at Dharmapuri on 22.09.1992 and retired from service on attaining the age of superannuation on 30.04.2020. The petitioner was serving as Selection Grade Senior Driver under the control of the 1st respondent. It had been stated that the Provident Fund, Gratuity and Earned Leave Salary was paid only on 02.06.2021, nearly one year and two months after the date of retirement. For that one year and two months delay, the petitioner seeks interest at 6% per annum. In this connection, the petitioner had given a representation dated 28.12.2024.



3.A direction is issued to the respondents to examine the representation dated 28.12.2024 given by the petitioner and pass appropriate orders within a period of four weeks from the date of receipt of a copy of this order.

4. With the above observations, this Writ Petition stands disposed of.
