ORDER

This petition has been filed by A3 seeking to quash the F.I.R.No.189/2023 dated 19.07.2023 registered by the 1st respondent Police for the offences punishable under Sections 409, 420, 465, 467, 468, 471 and 120B of I.P.C, based on the complaint given by the 2nd respondent.

Therefore, the respondent police has deleted his name in the Final Report. The Final Report deleting his name will be filed soon.
