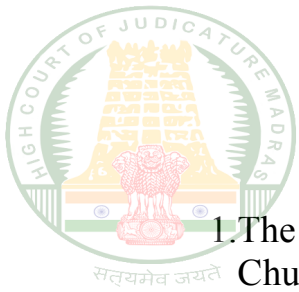

**Prayer in W.P.No.24211 of 2006 :** Writ Petition is filed under Article 226 of the Constitution of India, to issue a Writ of certiorarified mandamus calling for records of the 6<sup>th</sup> respondent in its proceedings Mu.M.No.52298/W29/2004 dated 06/07/2005 and the letter of the 5<sup>th</sup> respondent in O.M.No.5464/A1/2004 dated 29/08/2005 quash the same and consequently direct the respondents 1 to 6 to reinstate the petitioner into service as P.G. Asst (English) and regularize his services from the date of his appointment with all consequential and other monetary benefits.

**Prayer in W.P.No.19398 of 2008 :** Writ Petition is filed under Article 226 of the Constitution of India, to issue a Writ of Mandamus, directing the third respondents to give appointment to the petitioner as Post Graduate Assistant in English in a permanent post in any of the Schools of the first and second respondent and forbear the respondents 3 to 8 from approving the promotion and appointment of any one of the 9<sup>th</sup> and 10<sup>th</sup> respondents.

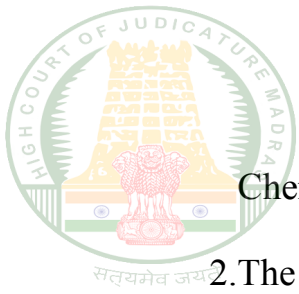
