4. Post the matter on 07.04.2025.

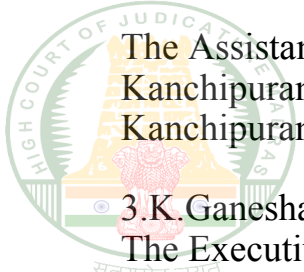
