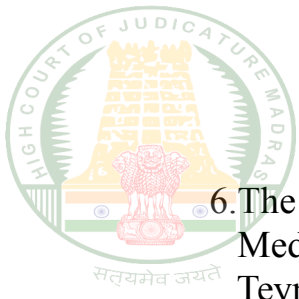

" I may be permitted to withdraw the writ appeal."



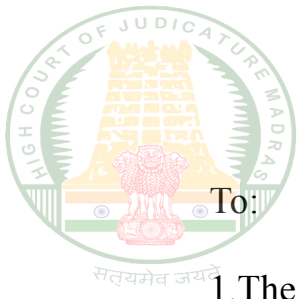
2. In view of the same, this Writ Appeal is dismissed as withdrawn.
