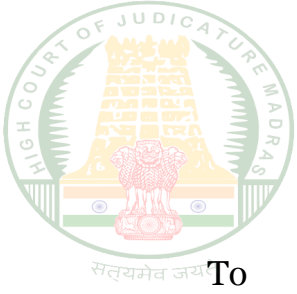
4. In view thereof, petition is disposed of. There shall be no order as to costs. Consequently, interim application is disposed of.
