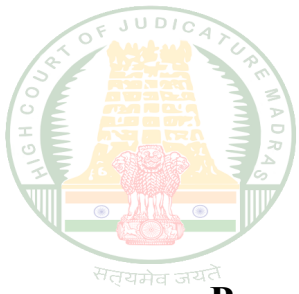

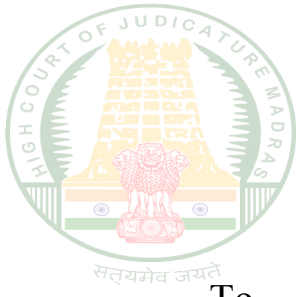
3. Therefore, this Court suo motu impleads the District Revenue Officer, Krishnagiri, as the 4th respondent in this Writ Petition.
