Prayer: Writ Petition is filed under Article 226 of the Constitution of India, to issue a Writ of mandamus for the following reliefs:-

(i) to direct the respondents to issue the order of up-gradation and promotion order to the petitioner to the post of Electrical Inspector in terms of G.O.Ms.No.1633 PWD dated 25.11.1992 or otherwise on the basis of performance revealed in the Annual confidential records from 1985 onwards and to direct the respondents to consider and to promote the petitioner to the consequential promotional post of Senior Electrical Inspector from the date



on which the third respondent is further promoted as Chief Electrical Inspector to the Government (Incharge) and to consider the claims of the petitioner for the post of Chief Electrical Inspector along with the third respondent and to promote to the said post and grant such further or other appropriate orders as this Hon'ble Tribunal may deem fit and proper in the facts and circumstances of the case and thus render justice.

(ii) to grant such further or other reliefs as this Hon'ble Court may deem fit and proper in the facts and circumstances of the case and render justice.
