2. In view of the said submission, this writ petition is closed . There shall be no order as to costs.

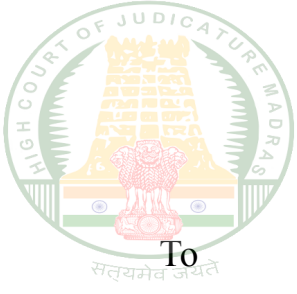
