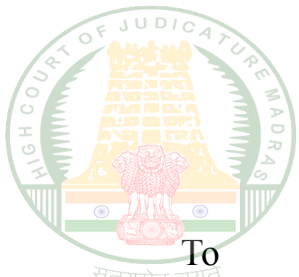
3. When the matter was taken up for hearing today, the learned Standing counsel appearing for the 2nd respondent placed the proceedings of the RDO, Sriperumbudur dated 31.03.2023. This order was passed by the RDO based on the application that was submitted by Dhanasekaran, who has been impleaded as the 4th petitioner in the place of the original writ petitioner, who died during the pendency of the writ petition.
