It is respectfully submitted that on receipt of the report of Deputy Superintendent of Police, Social Justice and Human Rights Wing, SC/ST Cell, Tirupur, the State Level Scrutiny Committee has sent summon dated 08.01.2025 to the petitioner to appear before the committee on 24.01.2025 for giving opportunity to the petitioner and to submit relevant documents to substantiate his community claim.”

3. In light of the above status report, the authorities are at liberty to pursue all further actions in the manner known to law.

4. With this liberty, the Writ Petition stands dismissed as withdrawn.
