2. The case of the petitioner is that the petitioner has made a representation on 10.01.2025 before the respondents to provide backwages and the other attendant benefits as per the order dated 01.04.2022 passed in I.D.No.15 of 2018, by the Additional Labour Court, Coimbatore and the order of this Court dated 07.08.2024 passed in W.P.No.28881 of 2022, however, the same has not been considered so far. Therefore, the petitioner has filed the present writ petition with the aforesaid prayer.

3. The learned counsel appearing for the petitioner would submit that it would suffice, if the respondents are directed to dispose of the representation of the petitioner, dated 10.01.2025, on merits and in accordance with law, within a specified period.
