ORDER

respondent to deal with the representation made by the petitioner on 02.02.2022 and pass orders on its own merits and in accordance with law after affording opportunity to respondents 5 to 7 and final orders shall be passed, within a period of eight weeks from the date of receipt of copy of this order. The petitioner is directed to make a fresh representation to the 2nd respondent along with the earlier representation dated 02.02.2022 and all the relevant documents and also a copy of this order.

4.This writ petition is disposed of with the above directions. No Costs.
