The writ petition is filed challenging the order passed by the 3rd respondent seeking to enforce the order passed against the petitioner under Section 78 of HR & CE Act.

2. It is not in dispute that proceeding has been initiated against the petitioner for eviction under Section 78 of HR & CE Act in M.P.No.49 of 2009 on the file of 2nd respondent. The said proceedings culminated in passing of eviction order against the petitioner as early as 06.10.2010.
