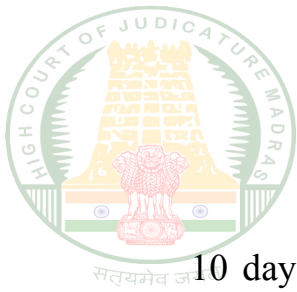

2. In view of the submission and endorsement made by the learned counsel for the petitioner, this Writ Petition stands dismissed as withdrawn. No costs.

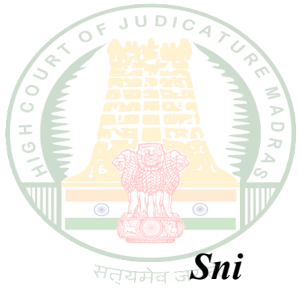
