ORDER

Petition seeking bail in respect of Crime No.42 of 2025 registered for the offences punishable under Section 310(2) of BNS, is on board for consideration.

2. The incarceration of the petitioners being from 06.01.2025, pleading innocence on the part of the petitioners and false implication in the case, learned counsel for the petitioners seeks indulgence of this Court. He also submits that the petitioners are in no way connected with the alleged offence, however, the present case has been foisted against them only for a statistical purpose. He further submits that the petitioners are ready to abide by any stringent condition that may be imposed by this court.

3. The case of the prosecution as putforth by the learned Government Advocate (Criminal Side) appearing for the respondent police, opposing for grant of bail, is that the accused had committed theft of 7 ¼ sovereigns of gold chain from the house of the de facto complainant. He further submits that the stolen jewel was recovered and the case is under investigation. He also submits that the petitioners herein are arrayed as A2 and A5 and against A2, seven previous cases are pending and in respect of A5, one previous case is pending.

4. Having heard the learned counsel for the petitioners and the learned Government Advocate (Criminal Side) for the respondent Police and perused the materials available on record and considering the period of incarceration undergone by the second petitioner, this Court is inclined to grant bail to the second petitioner alone with certain conditions and further, considering the

antecedents of the first petitioner, this Court is not inclined to grant bail to the first petitioner.

5. Accordingly, the Criminal Original Petition in respect of the first petitioner stands dismissed and the Criminal Original Petition in respect of the second petitioner stands ordered. Thereby, the second petitioner is ordered to be released on bail on his executing a bond for a sum of **Rs.15,000/- (Rupees Fifteen Thousand only)** with **two sureties (out of which, one of the sureties should be the blood related surety of the second petitioner)**, each for a like sum to the satisfaction of the learned **Judicial Magistrate No.2, Tiruppur**, and on further conditions that :

[a] the sureties shall affix their photographs and Left Thumb Impression in the surety bond and the Magistrate may obtain a copy of their Aadhar card or Bank pass Book to ensure their identity;

[b] the second petitioner shall report before the respondent Police, everyday at 06.30 p.m., until further orders;

[c] the second petitioner shall not abscond either during investigation or trial;

[d] the second petitioner shall not tamper with evidence or witness either during investigation or trial;

[e] On breach of any of the aforesaid conditions, the learned Magistrate/Trial Court is entitled to take appropriate action against the second petitioner in accordance with law as if the conditions have been imposed and the second petitioner released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in ***P.K.Shaji vs. State of Kerala [(2005)AIR SCW 5560]***;

[f] If the accused thereafter absconds, a fresh FIR can be registered under Section 269 of B.N.S.
