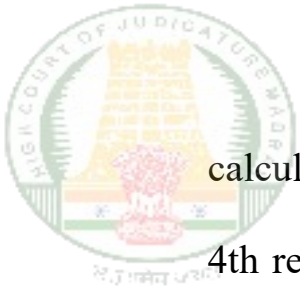

Prayer: Writ Petition is filed under Section 226 of the Constitution of India for issue of Writ of Certiorarified Mandamus, calling for the records pertaining to the impugned order made in Memo issued by the 3rd respondent Memo No.1861/SE/CEDC/S-I/Adm3/A1/ F.Sel. Gr/2022 dated 21.10.2022 and the consequential order in Memo issued by the fourth respondent in Memo N0.2081/EE/O&M/ Porur/Admo/ Ads/A2/ F.Pay- Fix/2022 dated 26.10.2022 related to pay fixation arrears
