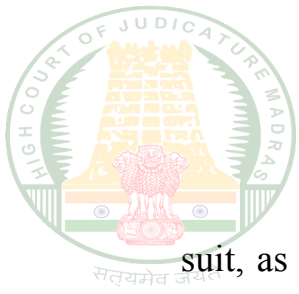

ORDER

This petition has been filed for direction directing the respondents 1 to 3, to provide police protection to enter into his premises and to renovate the structure in respect of the property comprised survey No.1206/2, situated at Anthevanapalli Village, Denkanikottai, Krishnagiri District, to an extent of one cent.

2. The learned counsel appearing for the respondents 4, 9 to 11 submitted that there is dispute between the petitioner and the respondents 4 to 11 in respect of the subject property. Further, already the petitioner filed
