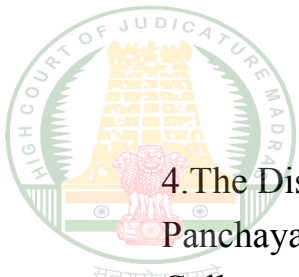

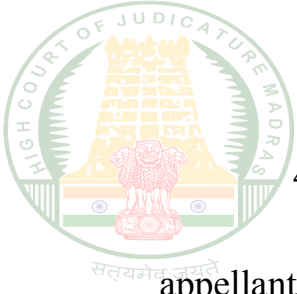
JUDGMENT
