However, the process is now being resumed by the Election Officer, who will be nominated by the 1st respondent and the election will be conducted as expeditiously as possible.

3. In view of the above submission made by the learned Additional Government Pleader, this Writ Petition stands disposed of. Consequently, the connected Miscellaneous Petition is closed. There shall be no order as to costs.
