**PRAYER in CRL OP No. 2782 of 2025**

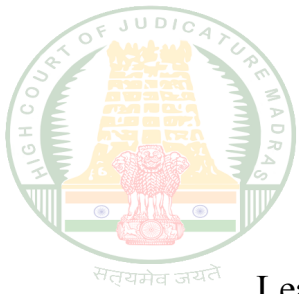
