2. Heard the learned counsel appearing on either side and perused the materials available on record.

It is seen that while suspending sentence, this Court by an order dated 04.07.2024, imposed condition in Crl.M.P.No.16761 of 2023 in Crl.A.No.491 of 2023, thereby directed the petitioner to appear before the respondent police on every Monday at 10.30 a.m. To relax the said condition, the petitioner filed the present petition.

4. The learned Additional Public Prosecutor appearing for the respondent police submitted that after enlarging on bail, he had committed another offence similar in nature, and therefore, he was
