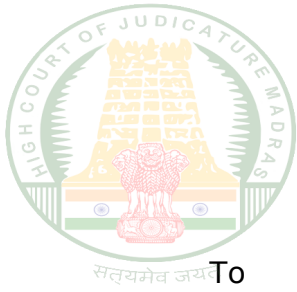
None for the petitioner.
