Order

Mr.Gokulakrishnan states that he requires six more months time to vacate the public road. This Court, by an order dated 05.08.2024 had granted a period of six months time, which expired long ago. This petition seeking further time was filed in January and we are in December. Further six months time would prevent persons from using the road till June 2026.

2. I am not inclined to grant such time whereby the petitioner will continue to occupy the public road. When this was pointed out to Mr.Gokulakrishnan, he states that time may be granted till Pongal festival. Hence, time is extended till **18.01.2026**. In case the petitioner does not hand over possession thereafter, the respondents 2 and 3 shall take immediate steps to ensure that the road remains free of any encroachment. The petition is allowed in the above terms.
