2. With this, and as nothing further remains in this Writ Appeal, the same is closed. No costs. Connected Miscellaneous Petition is also closed.

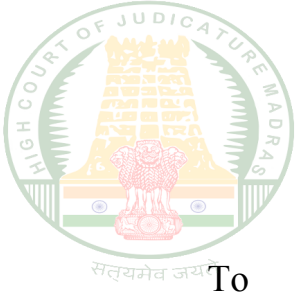
