3.The reasons for seeking the transfer are as follows:-

a)The petitioner is a resident of Ernavoor which falls within the jurisdiction of the Sub Court, Tiruvottriyur and if she has to travel to attend the hearing in H.M.O.P.No.112 of 2020, she would have to undertake a overnight travel for every hearing.

b)The petitioner has filed M.C.No.12 of 2021 on the file of the Sub Court, Tiruvottriyur which clearly indicates that the husband has not been maintaining the wife.

3.Heard the learned counsel for the petitioner and perused the records.

4.Considering the above reasons which are justifiable, the request of the petitioner can be granted. Therefore, this Transfer Civil Miscellaneous Petition is allowed and H.M.O.P.No.112 of 2020 is
