2. Despite service of notice on the respondent, the respondent failed to appear before this Court either in person or through counsel. The respondent is called and set ex-parte.

3. I also gone through the affidavit filed in support of the transfer application. The petitioner is the wife, who is facing the divorce proceedings initiated by the respondent/husband. The petitioner is the resident of Chennai and she has expressed inconvenience to travel all the way to Villupuram to attend the proceedings initiated by the respondent/husband.
