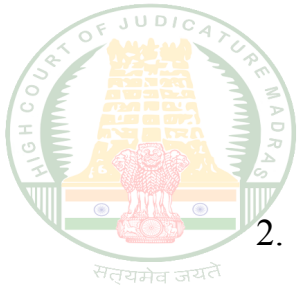
PRAYER
