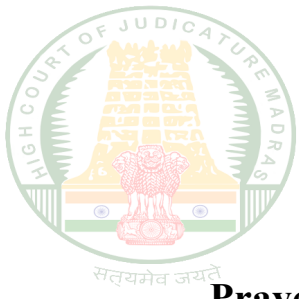

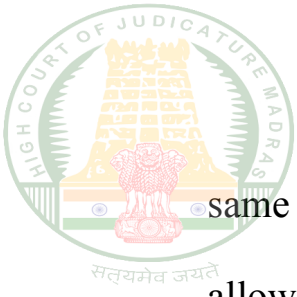

COMMON ORDER

Challenging the orders passed in IA.Nos.1 to 3 of 2022 in O.S.No.4393 of 2010 on the file of the II Assistant City Civil Court, Chennai the petitioner / plaintiff is before this Court. The applications have been filed to condone the delay of 1088 days in filing the application to set aside the abatement, to set aside the abatement and to bring on record the 8th defendant as the legal heir of the deceased 3rd defendant, in the suit.

same has now been produced the Civil Revision Petitions may be allowed.

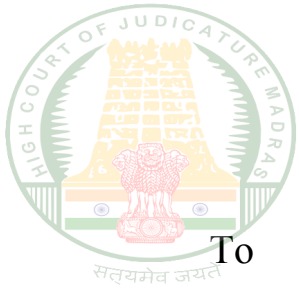
