"9. I respectfully submit that from the enquiry it reveals that already

- i. The counter petitioner has filed a Civil Suit in O.S.No.50 of 2017 before the learned Sub Court, Ponneri and also filed a I.A.No.117 of 2017 for the interim injunction against the petitioner. There is no interim order has been granted in the I.A.No.117 of 2017.*
- ii. Already there is an FIR has been registered in Crime No.676 of 2018, the same has been referred to the RDO, Ponneri on 16.03.2019 in u/s.107 Cr.P.C. and the enquiry is still pending.*
- iii. In respect of the management of Trust, the respondent police directed both the parties to approach District Registrar since it is competent forum to adjudicate issue related to trustees.*
- iv. There is no issue is pending in respect of performing Pooja and Punaskaras between the parties.*
