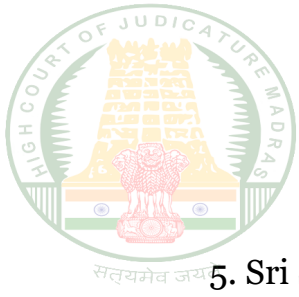

There shall be no order as to costs.

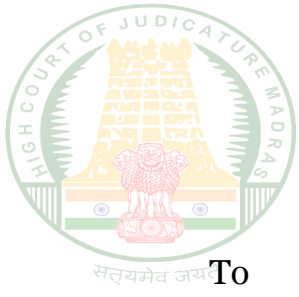
