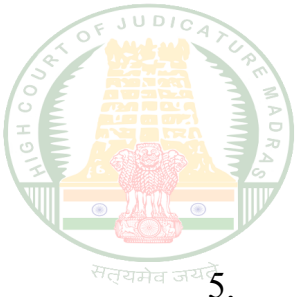

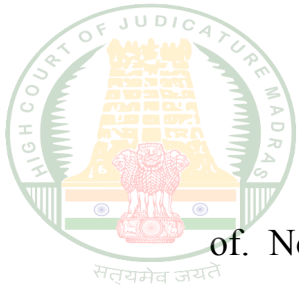
“Notice to the 3rd and 4th respondents through Court as well as privately, returnable by 07.03.2025.
