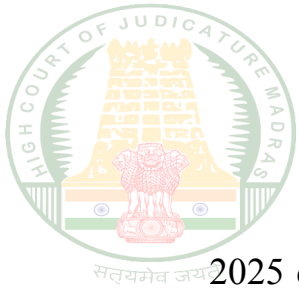
ORDER

The petitioner seeks modification of the condition directing him to report before the respondent police every day at 10.00 a.m., until further orders imposed by this Court in Crl.O.P.No.1150 of 2025 dated 17.01.2025.

The learned counsel for the petitioner would submit that the petitioner was released on bail on 17.01.2025, and when he came out of the jail, the respondent arrested him in another case, and the learned Magistrate had released him on bail in the said case, directing him to appear before the learned Judicial Magistrate No. II, Alandur, on all working days; and that the very same condition may be imposed in this case also.

3. Heard the learned Government Advocate (Crl.Side) for the respondent.

4. Considering the aforesaid facts, this Court is inclined to modify the condition in para no.3(c) imposed on the petitioner in Crl.O.P.No.1150 of
