3. Pursuant to the above order, the matter was listed for hearing today.

The learned Additional Government Pleader appearing on behalf of respondents 4 and 5 produced the written instructions received from the 4th respondent. On going through the same, it is stated that there is no proposal to lay any road in the patta land belonging to the petitioner.

4. Recording the above, this writ petition is disposed of. No costs.

Consequently, the connected miscellaneous petition is closed.

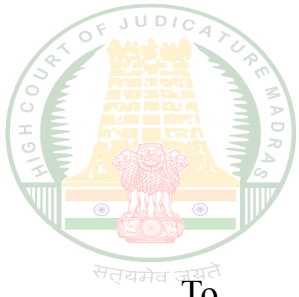
