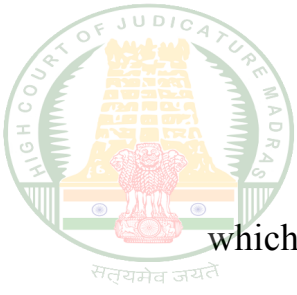
### **ORDER**

3.Heard the learned Standing Counsel for the respondents.

4.The respondents may examine the service register of each one of the petitioners and examine whether the salary for the last 10/11 days, for

which, they have worked had been paid to them and if not, pay the same within a period of three months from the date of receipt of a copy of this order. It would also carry an interest at 6% per annum from the date of retirement till the date of actual disbursement.
