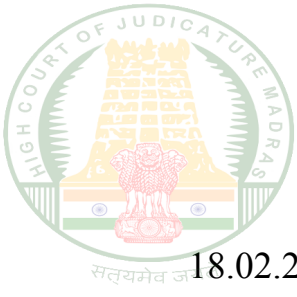

3.Recording the submission of the learned Additional Public Prosecutor, this writ petition is dismissed as infructuous. No costs.

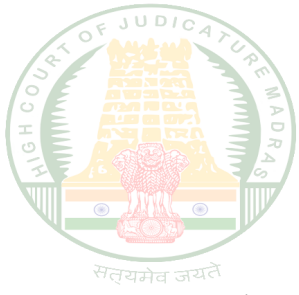
