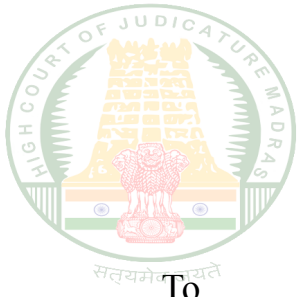
which was rejected by the 3rd respondent through proceedings dated 28.12.2022.

It goes without saying that the petitioner must be given an opportunity at the time of hearing the appeal.
