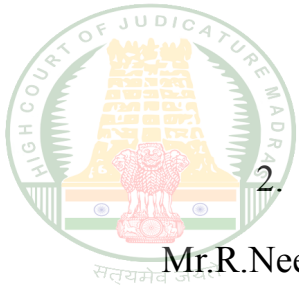

Ultimately, the third respondent has to give an opportunity to the petitioner and respondents 5 to 9, and a decision must be taken. If no decision has been taken till date, the third respondent can proceed further with the enquiry and pass appropriate orders. Accordingly, the writ petition stands disposed of. No costs. Consequently, any connected miscellaneous petitions are closed.
