ORDER

The petitioner / Accused No.1, who apprehends arrest in the hands
of the respondent police for the offences punishable under Sections 379

and 430 of IPC and Section 21(1) of Mines and Minerals (Development and Regulation) Act in connection with the case in Crime No.105 of 2020, seeks anticipatory bail.

2. The case of the prosecution is that on 28.02.2020, the petitioner had illegally transported 1 unit of river sand in a vehicle Xenon Pickup Van bearing Registration No.TN23-BK-3484.

3. Learned counsel for the petitioner would contend that the petitioner is an innocent and he is the driver of the vehicle; that he has not committed any offence; that the materials and the vehicle were seized; and that the custodial interrogation is not required in this case and hence prayed to grant anticipatory bail to the petitioner.

4. The learned Government Advocate (Criminal Side), per contra, would submit that the respondent police seized the materials and confirmed that one previous case, which is of the year 2020, is pending against the petitioner.

5. Heard the learned counsel for the petitioner and the learned Government Advocate (Crl.Side) for the respondent police and perused the materials available on record.

6. Considering the nature of allegations, the fact that though the petitioner has one previous case of similar nature, it was registered in the year 2020, that the properties were seized by the respondent police and since the custodial interrogation of the petitioner is not required for the purpose of investigation, this Court is inclined to grant anticipatory bail to the petitioner on certain conditions.

7. Accordingly, the petitioner is ordered to be released on bail in the event of arrest or on his appearance within a period of fifteen days from the date of receipt of a copy of this order, before the learned **Judicial Magistrate, Katpadi** on condition that the petitioner shall execute a bond for a sum of **Rs.10,000/- (Rupees Ten Thousand only)**, with two sureties each for a like sum to the satisfaction of the respondent

Police or the Police officer who intends to arrest or to the satisfaction of the learned Magistrate concerned, failing which, the petition for anticipatory bail shall stand dismissed and on further conditions that:

[a] the petitioner and the sureties shall affix their photographs and Left Thumb Impression in the surety bond and the Magistrate may obtain a copy of their Aadhar card or Bank pass Book to ensure their identity.

[c] the petitioner shall report before the respondent police everyday at 10.30 a.m., until further orders.

[d] the petitioner shall not tamper with evidence or witness either during investigation or trial.

[e] the petitioner shall not abscond either during investigation or trial.

[f] On breach of any of the aforesaid conditions, the learned Magistrate/Trial Court is entitled to take appropriate action against the petitioner in accordance with law as if the conditions have been imposed and the petitioner released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in P.K.Shaji vs. State
