### ORDER

(Order of the Court was made by the Hon'ble Chief Justice)

Mr.Prabhakar appears for respondents 1 to 4 and states that survey, in the presence of petitioner, was conducted in response to the representation received, and eight encroachments were found; two of which were removed forthwith. He states, as regards other six encroachments, notice under Section 7 of the Tamil Nadu Land Encroachment Act, 1905 was issued to encroachers and thereafter, final notice dated 3 June 2025 under Section 6 of the said Act has also been issued, and 15 days' time granted to the encroachers to remove the encroachments.
