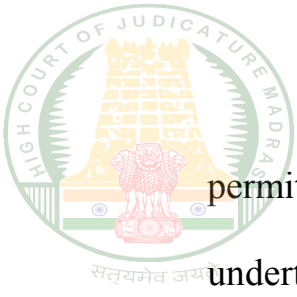

COMMON ORDER

Though these two writ petitions have been filed challenging the 23rd Governing Body's Resolution dated 22.11.2010 with specific reference to Clause 23.27.0, and the consequential regularization order issued in favour of the 8th respondent, taking into consideration the long lapse of time, the learned counsel for the petitioner submitted that the petitioner is no longer interested in pursuing these writ petitions.
