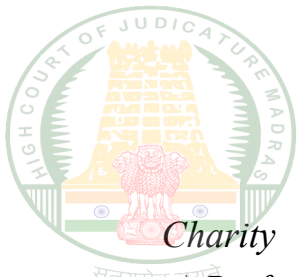

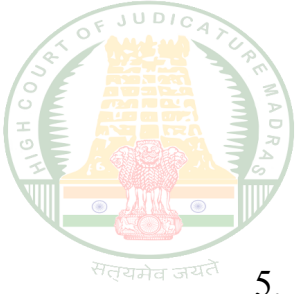
a) Poor feeding during Brahmotchavam at Tiruvotriyur, Chennai – 19.
