No costs. Consequently, connected miscellaneous petitions are closed.

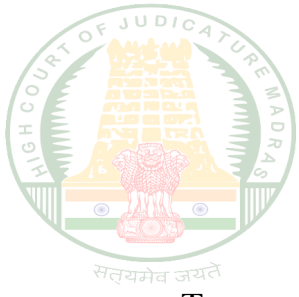
