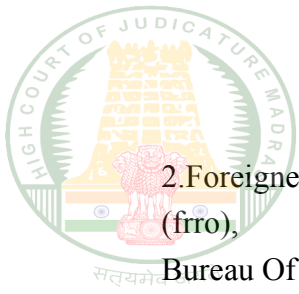

ORDER

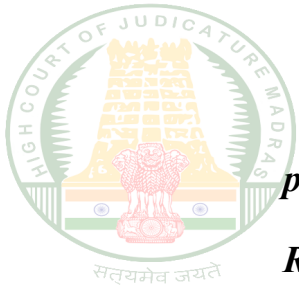
The above matter is listed today under the caption “for being mentioned”.

The petitioners shall pay a sum of Rs.2,000/- each, (Rupees Two Thousand only) as costs, to the Chief Justice Relief Fund, Tamil Nadu, within a period of one week from the date of receipt of a copy of this order and file a photocopy of the receipt along with a memo reporting compliance in the Registry. It is made clear that the accused have entered into a compromise. Therefore, any lookout circular pending as against the accused have become infructuous. The petitioners can visit abroad if not involved in any other case.”

2. Accordingly, the Registry is directed to issue a fresh order copy in Crl.O.P.No.3967 of 2025 dated 17.02.2025 after making necessary corrections.
